**Section 4. First aid measures**

<b>Ingestion:</b>	Ensure that breathing passages are not obstructed. The product will polymerise immediately in the mouth making it almost impossible to swallow. Saliva will slowly separate the solidified product from the mouth (several hours).
<b>Skin:</b>	Do not pull bonded skin apart. It may be gently peeled apart using a blunt object such as a spoon, preferably after soaking in warm soapy water. Cyanoacrylates give off heat on solidification. In rare cases a large drop will generate enough heat to cause a burn. Burns should be treated normally after the adhesive has been removed from the skin. If lips are accidentally stuck together apply warm water to the lips and encourage maximum wetting and pressure from saliva inside the mouth. Peel or roll lips apart. Do not try to pull the lips apart with direct opposing action.

<b>Eyes:</b>	If the eye is bonded closed, release eyelashes with warm water by covering with wet pad. Cyanoacrylate will bond to eye protein and will cause periods of weeping which will help to debond the adhesive. Keep eye covered until debonding is complete, usually within 1-3 days. Do not force eye open. Medical advice should be sought in case solid particles of cyanoacrylate trapped behind the eyelid cause any abrasive damage.
<b>Inhalation:</b>	Move to fresh air, consult doctor if complaint persists.
<b>First Aid facilities:</b>	Eye wash and safety shower Normal washroom facilities
<b>Medical attention and special treatment:</b>	Treat symptomatically.  Surgery is not necessary to separate accidentally bonded tissues. Experience has shown that bonded tissues are best treated by passive, non-surgical first aid. If rapid curing has caused thermal burns they should be treated symptomatically after adhesive is removed.

### Section 5. Fire fighting measures

<b>Suitable extinguishing media:</b>	Foam, extinguishing powder, carbon dioxide. Fine water spray
<b>Improper extinguishing media:</b>	High pressure waterjet

<b>Personal precautions:</b>	Ensure adequate ventilation. Avoid skin and eye contact. Wear protective equipment.

<b>Clean-up methods:</b>	Do not use cloths for mopping up. Flood with water to complete polymerization and scrape off the floor. Cured material can be disposed of as non-hazardous waste. Dispose of contaminated material as waste according to Section 13.

### Section 7. Handling and storage

<b>Precautions for safe handling:</b>	Prevent contact with eyes, skin and clothing. Do not breathe vapor and mist. Wash thoroughly after handling. Avoid contact with fabric or paper goods. Contact with these materials may cause rapid polymerization which can generate smoke and strong irritating vapors, and cause thermal burns.
<b>Conditions for safe storage:</b>	Store in a cool place in closed original container. For optimum shelf life store in original containers under refrigerated conditions at 2 - 8°C (35.6 - 46.4 °F)

Protective clothing that covers arms and legs.

Polyethylene or polypropylene gloves are recommended when using large volumes.  
Do not use PVC, rubber or nylon gloves.

**Section 11. Toxicological information**

**Health Effects:**

**Ingestion:** Not expected to be harmful by ingestion. Rapidly polymerizes (solidifies) and bonds in mouth. It is almost impossible to swallow.

**Skin:** Bonds skin in seconds. May cause skin irritation. Cyanoacrylates have been reported to cause allergic reaction but due to rapid polymerization at the skin surface, an allergic response is rare. Cyanoacrylates generate heat on solidification. In rare circumstances a large drop will burn the skin. Cured adhesive does not present a health hazard even if bonded to the skin.

**Eyes:** Irritating to eyes. Causes excessive tearing. Eyelids may bond.

**Inhalation:** Exposure to vapors above the established exposure limit results in respiratory irritation, which may lead to difficulty in breathing and tightness in the chest.
