<b>MINERAL OIL</b>	<p>The materials included in the Lubricating Base Oils category are related from both process and physical-chemical perspectives; The potential toxicity of a specific distillate base oil is inversely related to the severity or extent of processing the oil has undergone, since:</p> <ul style="list-style-type: none"> <li>• The adverse effects of these materials are associated with undesirable components, and</li> <li>• The levels of the undesirable components are inversely related to the degree of processing;</li> <li>• Distillate base oils receiving the same degree or extent of processing will have similar toxicities;</li> <li>• The potential toxicity of residual base oils is independent of the degree of processing the oil receives.</li> <li>• The reproductive and developmental toxicity of the distillate base oils is inversely related to the degree of processing.</li> </ul> <p>Unrefined &amp; mildly refined distillate base oils contain the highest levels of undesirable components, have the largest variation of hydrocarbon molecules and have shown the highest potential cancer-causing and mutation-causing activities. This may be due to a non-allergic condition known as reactive airways dysfunction syndrome (RADS) which can occur after exposure to high levels of highly irritating compound. Main criteria for diagnosing RADS include the absence of previous airways disease in a non-atopic individual, with sudden onset of persistent asthma-like symptoms within minutes to hours of a documented exposure to the irritant. Other criteria for diagnosis of RADS include a reversible airflow pattern on lung function tests, moderate to severe bronchial hyperreactivity on methacholine challenge testing, and the lack of minimal lymphocytic inflammation, without eosinophilia. No significant acute toxicological data identified in literature search.</p>
