PORTLAND CEMENT

The following information refers to contact allergens as a group and may not be specific to this product.

The pathogenesis of contact eczema involves a cell-mediated (T lymphocytes) immune reaction of the delayed type. Other allergic skin reactions, e.g. contact urticaria, involve antibody-mediated immune reactions.

Asthma-like symptoms may continue for months or even years after exposure to the material ends. This may be due to a nonallergic condition known as reactive airways dysfunction syndrome (RADS) which can occur after exposure to high levels of highly irritating compound.
